I. Introduction

SGP Indonesia is a Small Grant Program in Indonesia which is a collaboration program at the Southeast Asia level between The ASEAN Center for Biodiversity (ACB) and the Government of Indonesia through the Ministry of Environment and Forestry (KLHK) cq. Directorate General of Conservation of Natural Resources and Ecosystems (Dirjen KSDAE). Program funding support was obtained from the German Government through the German Financial Cooperation/KfW (BMZ No. 2011 66545). This cooperation is contained in a Memorandum of Understanding (MSP) signed by KLHK cq. The Directorate of Conservation of Natural Resources and Ecosystems together with the ACB Executive Director dated May 21, 2015 in Jakarta.

In Indonesia, the ASEAN Centre for Biodiversity (ACB) mandates the Penabulu Foundation to become an SGP Indonesia Service Provider to provide assistance and assistance in the implementation of small grants and micro grants. Penabulu Foundation will coordinate with KLHK cq. Directorate General of Natural Resources and Ecosystems cq. Directorate of Biodiversity Conservation as a Project Implementing Agency (PIA) through the National Steering Committee (NSC) and National Working Team (NWT).

Micro grants are given to carry out the supporting activities needed to support SGP Indonesia in general and the strengthening of the ASEAN Heritage Park (AHP) in Indonesia, namely the Gunung Leuser National Park (GLNP) and Way Kambas National Park (WKNP). The determination of needs will be determined based on the Service Provider's consultation with KLHK which in this case is represented by KKH.

II. Micro Grant Supports

Based on consultations between the Penabulu Foundation as Service Provider and KKH as PIA on February 21, 2020 at the KKH Office, which provides direction for activities to support SGP Indonesia in the form of Micro Grants, as follows:

- Conflict resolution in conservation areas and surrounding areas, including conflicts between animals and humans.
- AHP documentation in Indonesia in the form of videos and books
- Training and/or Coaching Clinic

- Outreach or Media Campaign related in environment activities and natural resource in AHP Indonesia
- Or, activities that support AHP protection (TNWK and TNGL) in Sumatra from depalan (8) SGP Indonesia's theme based on the Collaborative Management Plan of each national park, namely:
 1. National parks management
 2. Habitat and Species
 3. Law Enforcement
 4. Community Development
 5. Research and Wildlife Monitoring
 6. Outreach and Public Awareness
 7. Eco tourism
 8. Policy Sectoral Development

The activity above is determined by looking at current conditions and needs in the near future. Activities that can be supported by Micro Grants can change according to the needs that are considered important based on SP recommendations that are approved or recommended by the Directorate of KKH, DG KSDAE, Ministry of Environment of the Republic of Indonesia.

III. Micro Grant Financial Supports

The total allocation of micro grant funds with a total value of EUR 50,000 or a maximum of EUR 5,000 per applicant for micro grants.

The micro grant project may not be 80% of the eligible costs. The applicant is committed to making their own contribution of at least 20% of the cost of the project that meets the requirements in the form of in-kind, for example: voluntary work, and or can also be in cash.

Disbursement of funds will be made at 90% of the project value when the Grant Agreement is signed and 10% of the project value after the final report is approved by the Servicer Provider.

The source of Micro Grants comes from the German Financial Cooperation Fund with the ASEAN Center for Biodiversity KfW Ref. BMZ 2011 66545, managed by the Penabulu Foundation as a Service Provider.

IV. Ammount and Project Duration

Micro grants will be given a maximum of EUR 5,000 or equivalent to IDR 75,000,000 with a maximum work period of 6 months.

V. Stages of Selection

The stages of selection to the signing of the micro grant consist of the following stages:

The language used in the Micro Grants proposal can be in Indonesian or English if the applicant can write it in English, is more better.

- a) **Community Based Organizations** located around the area of GLNP and TNWK which have a Endorsement Letter from the local Village Head and a Letter of Recommendation from the Head of the TNGL Center / TNWK Office regarding their participation in the SGP Indonesia Micro-Grant Program.
- b) **Local or National Civil Society Organizations** in the form of Foundations/ Associations or University Study Centers that have: (1) Memorandum of Understanding (MSP) with the Directorate General of Conservation of Natural Resources and Ecosystems (Dirjen KSDAE) Ministry of Environment and Forestry (KLHK); or (2) Cooperation Agreement with the GLNP Office/WKNP Office; or (3) Letter of Recommendation from the Head of GLNP Office/WKNP

Office during the process of submitting the Cooperation Agreement; (4) Endorsement Letter of Local Village Leader **if** the CSOs/CBOs worked in the village surrounding the national park or buffer zone of the national park.
